The Petit Palais was built for the 1900 Universal Exhibition, like its neighbour the Grand Palais, on avenue Winston Churchill. It became a museum in 1902. Designed by Charles Girault, it is based on a trapezium shape and is made up of four wings around a semi-circular garden bordered by a richly decorated peristyle. The architect achieved a successful blend of traditional and modern architecture which is evident in the natural flow of visitors around the building and in the bold openings he created onto the Champs-Élysées gardens and inner courtyard garden.

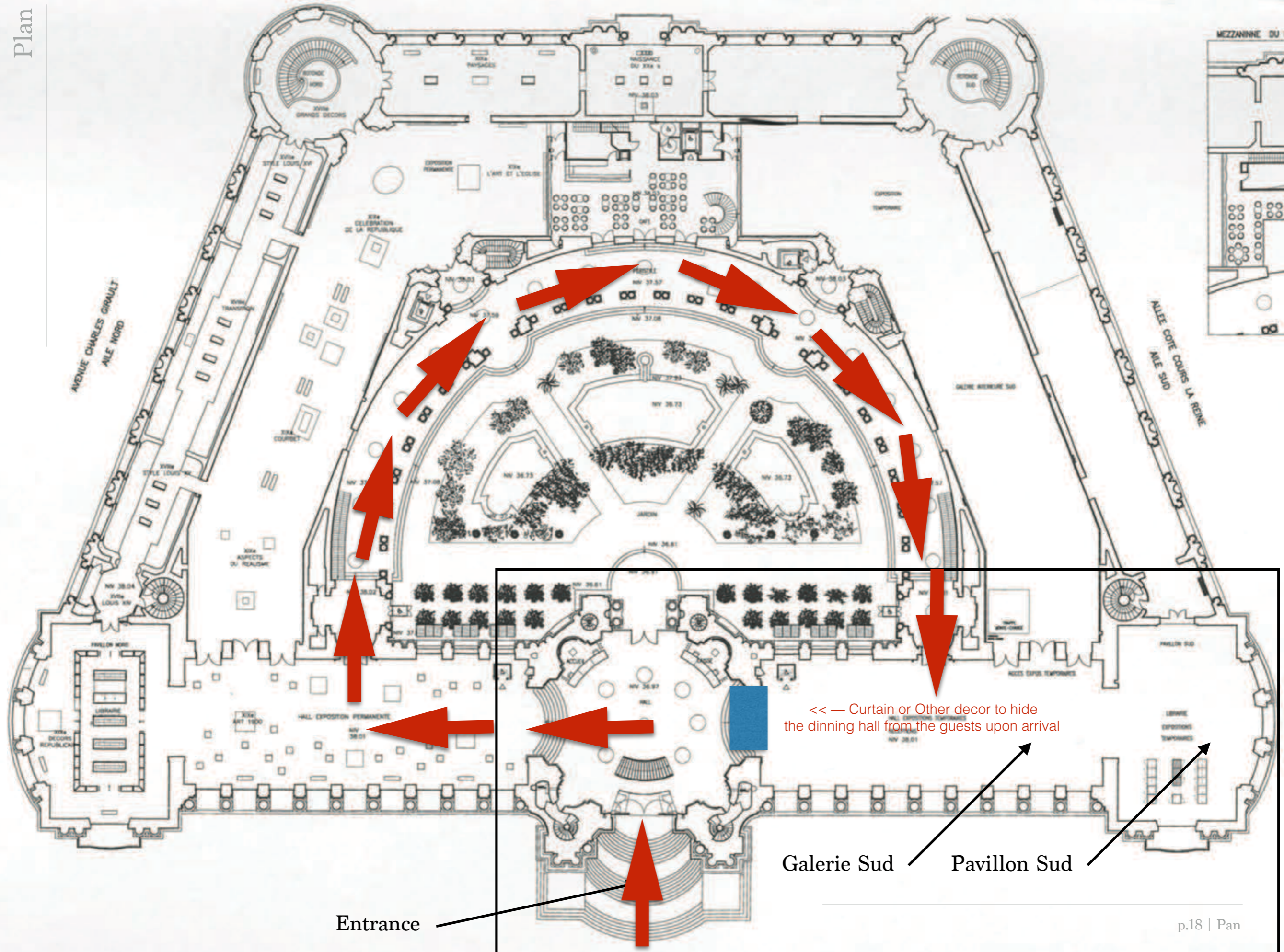










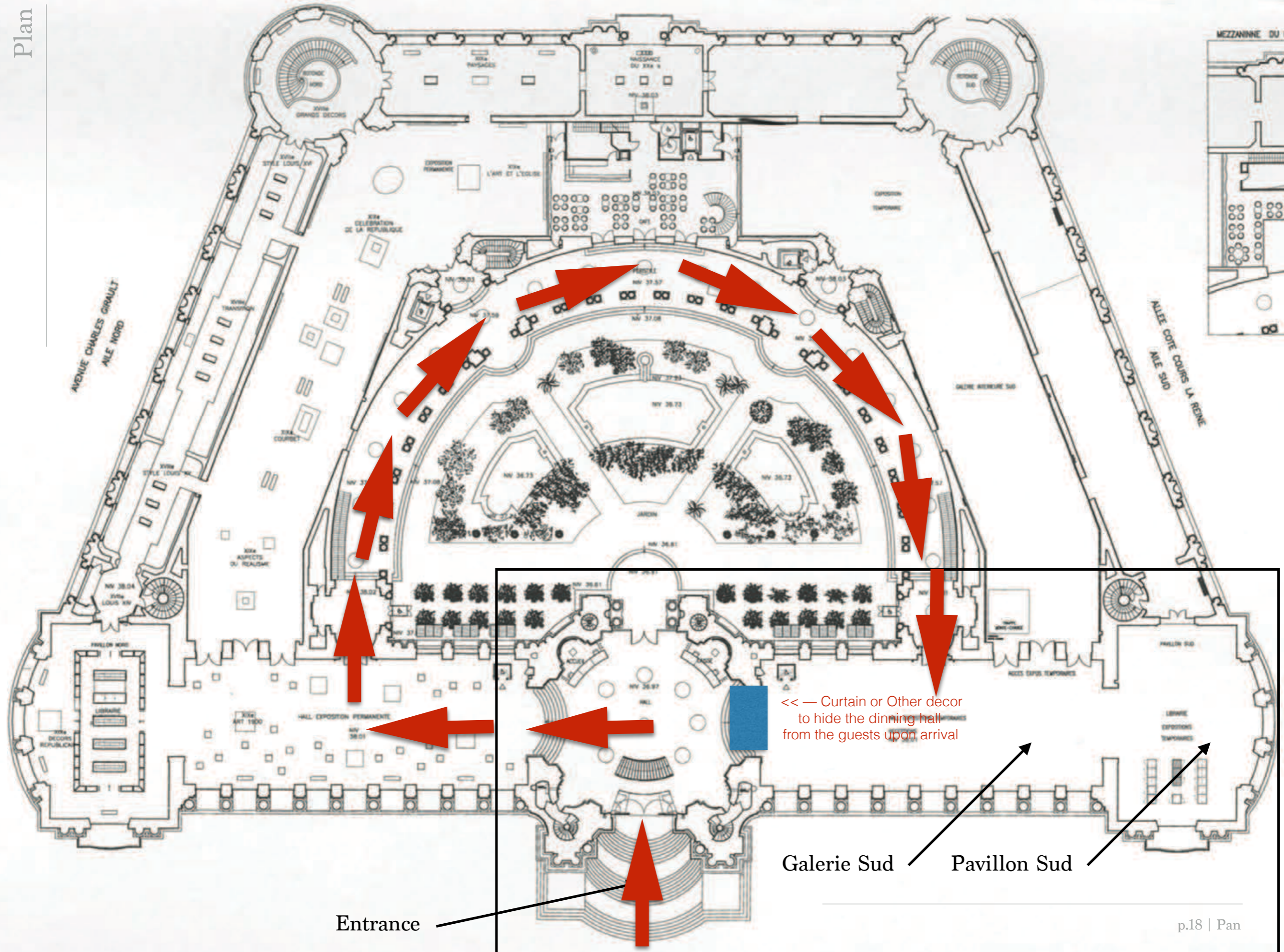

GENERAL TERMS AND CONDITIONS

1- GENERAL PROVISIONS

These General Terms and Conditions of Sale govern the relationship between the Company GROUPE HAUSSMANN and its clients. Prior to the validation of purchase orders, the client will read these general conditions of sale which are at the end of each file.

Any order for a service by the client implies its compliance without reservation or restriction to these general terms and conditions of sale.

2- CONDITIONS OF RESERVATION AND REGULATIONS

Reservations are accepted following the reception of the signed order, the present general terms and conditions of sale, also signed, and a 50% deposit of the total amount of the event, tax included.

GROUPE HAUSSMANN guarantees the opening of the location on the condition of full payment of the amount, tax included, 7 business days before the day of the event.

The estimate of the number of guests must be received at least five business days before the date of the event.

Any change in this number must be communicated to us in writing. The decrease in the number of guests is limited to 10% of the number of guests approved when signing the purchase order. This figure will be considered for billing, even if the actual number of guests turns out to be lower.

However, if this number were to be exceeded, without us being notified at least five business days in advance, we would not be able to provide our services satisfactorily. This would be detrimental to your guests, and therefore our brand, and compel us, as compensation, to take the number of guests present into account for billing.

Any sum not paid on its due date will result in ipso facto late penalties calculated on the basis of one and a half times the amount of the currently legal interest rate. Any delay in payment may suspend current orders and cause the payment of any amount to be due, even if the due date has not passed, without prejudice to any other course of action.

3- ADDITIONAL SERVICES

GROUPE HAUSSMANN undertakes additional services only by the client's written request stating their conditions and prices. These services will be billed upon completion of the event and are payable by the client upon receipt of invoice.

4- CANCELLATION CONDITIONS

4.1- BY THE CLIENT

Any cancellation of a reservation (in writing only), whatever the cause, and even in cases of force majeure, in consideration of expenses incurred, will result in a lump sum payment of:

- a charge of 50% of the total amount, tax included, of the service if the cancellation occurs after signing the purchase order and between 90 days and 45 days before the date of event; or the loss of that amount if the deposit has already been paid,
- a charge of the total amount of the service, tax included, if the cancellation occurs less than 45 days before the scheduled date of the event.

On the explicit request of the client and after acceptance by GROUPE HAUSSMANN, GROUPE HAUSSMANN will study the possibility of a postponement of the contractual date of the service. This deferral will cause an increase in the initially quoted budget and the signing of a separate Purchase Order and corresponding detailed budget.

4.2- BY GROUPE HAUSSMANN

As a service provider, GROUPE HAUSSMANN is bound only within the limits of due care. Consequently, it can not be held responsible for cancellation due to a third party or in case of force majeure.

In the case of a cancellation by the reception venue, GROUPE HAUSSMANN will undertake every effort to place the event in another site of the same group (excluding weekends) and maintain the organization of the event.

In the case of not being able to carry out the agreed upon service, GROUPE HAUSSMANN is not liable for damages in any form.

In the event of the occurrence of force majeure, this order will be deemed void and monies received will be immediately returned. No other compensation can be claimed.

To constitute a case of force majeure, the event occurring must be described as unpredictable, unavoidable and external.

5- RESPONSIBILITIES AND GUARANTEES

As a service provider, GROUPE HAUSSMANN is bound only within the limits of due care.

The client and his insurers waive all recourse against GROUPE HAUSSMANN and its insurers for all direct or indirect damages suffered by the client and finding its origin in the performance of contractual services.

The client is the sole responsible party for damages arising from its acts or those of a third under its control (participants in the event, including outside contractors), or damages suffered or caused in the surroundings of the private event organized by GROUPE HAUSSMANN.

GROUPE HAUSSMANN can not be held responsible in case of theft or damage caused to property and equipment stored on its premises by the client or by third parties.

When a locker is included in our services, the submission of a ticket must be enforced upon its delivery.

We are not responsible for loss of the ticket. It is specified that GROUPE HAUSSMANN accepts no responsibility for the contents of bags and clothing pockets and items not covered by insurance.

In addition, the client agrees to take out insurance covering his civil liability where he may be held liable due to participation in the contracted services. GROUPE HAUSSMANN must receive the insurance certificate within eight (8) days before the day of the event. Failing to produce the aforementioned certificate within the period specified, or if the insurance taken out by the client clearly appears to be insufficient, GROUPE HAUSSMANN reserves the right, if it sees fit, to unilaterally terminate this agreement without compensation of any kind to the client.

In the case of using equipment not belonging to the establishment, the Client will produce a certificate of damages insurance covering the possible risks caused by the use of that equipment to GROUPE HAUSSMANN before the event.

6- GOVERNING LAW

The parties submit this contract, binding them to French law. Any dispute shall be submitted to the Paris Courts of Arbitration.

No complaint about the running of the event will be admissible after the day of the dispute and therefore can not lead to any remittance.

These general terms and conditions of sale are deemed accepted without reservation or restriction by the client.
